Contract for Semen Collection

I, _____(stallion owner) hereby agree to have the stallion _____(name of stallion) semen collected and processed by Alison J Fellows dba New England Breeders Service. This contract is written and administered under the laws of the Commonwealth of Massachusetts and any legal disputes arising from the servicing this contract will be conducted within the jurisdiction of Worcester County, Massachusetts. Both parties understand and accept the following terms:

Semen will be collected and processed in Winchendon, MA or on farm at stallions current residence, stallion owner understands not all stallions are candidates for shipped semen. New England Breeders Service cannot guarantee the quality or fertility of semen collected and processed nor can we guarantee a collection can be obtained.

Stallion must be free of any infectious or contagious disease or sickness. A current year's copy of coggins test is required with this contract. The stallion owner also certifies stallion has received all required annual inoculations as instructed by a licensed veterinarian prior to having any collections processed.

Alison J Fellows dba New England Breeders Service will not be held responsible for any stallions injury, death, disease, infection or otherwise, and by any cause whatsoever and the stallion owner agrees to hold Alison J. Fellows or New England Breeders Service, or its agents, or employees, harmless for any and all damages associated therewith.

Alison J Fellows dba New England Breeders Service will not be held responsible for any persons injury, death, or otherwise while the stallion is being collected and handled and by any cause whatsoever and the stallion owner agrees to hold Alison J Fellows dba New England Breeders Service Farm, or its agents, or employees, harmless for any and all damages associated therewith

Alison J Fellows dba New England Breeders Service is not responsible for lost, delayed or damaged semen.

Alison J Fellows dba New England Breeders Service reserves the right to amend this contract at any time.

Alison J Fellows dba New England Breeders Service reserves the right to decline any offer to contract to any stallion for any and all reasons.

The Stallion Owner agrees to pay any and all related costs associated with the breeding services rendered by Alison J Fellows dba New England Breeders Service (which are billed on a per-procedure basis), including, but not limited to any and all semen collection and processing fees, semen shipping fees, board, veterinarian fees, and any other related expenses. Stallion owner agrees to pay all charges when due and should stallion owner fail to do so, Alison J Fellows dba New England Breeders Service shall be entitled to recover any costs, expenses and attorney's fees expended in collection. In the event collection of Owner's account is placed in the hands of an attorney, Owner agrees a minimum fee of \$500.00 shall be assessed as attorney's fees.
